## The Cause

Delaware County CASA recruits, trains, and supports community volunteers who serve as Court Appointed Special Advocates for abused and neglected children.

The mission of CASA is to be a support structure for abused and neglected children in Delaware County. CASA volunteers serve as the voice of the child in court; providing information and perspective to assist the judge in making informed decisions that are in the best interest of the child.

In 2022:

- **3,454** CASA volunteers advocated for **18,918** children across the state
- **509** new volunteers were trained in 2022, spending nearly **15,000 hours** in initial training
- **348,213 hours** were volunteered
- Volunteers donated an estimated **\$31 million** in services by giving their time and themselves advocating for the most vulnerable children.
